Dear Mr. Jones:

Find enclosed amended reports for 1st Quarter (01/01/2012 - 03/31/2012), 12-Day Pre-Election (04/01/2012 - 04/18/2012), and 2nd Quarter (03/19/2012 - 06/30/2012).

Upon understanding the nature of the issue regarding itemization of expenses it was necessary to amend previous reports to properly follow contributions and expenses. Specifically, credit card purchases were itemized on date of purchase, not date of disbursement to financial institution. This has been corrected with the credit card payment being listed on the appropriate report with reportable purchases, purchased by credit card, entered after the credit card payment and indicated by the term "Memo Entry" or "Memo Entry - Paid by credit card".

Additionally, the following items were discovered. First, \$530 in 2nd quarter contributions were incidentally omitted from the report. This has been corrected. Second, two expenditures of \$100 were made by the candidates personal credit card to the Chatham County GOP for event attendance which were never reimbursed to the candidate. These have been removed from the report. Third, cash purchases were made at Sam's Club to support campaign Events. These purchases were made with the candidates personal funds and were not reimbursed in a timely fashion which led to previous cash-on-hand discrepancies. This has been corrected.
