This letter is prompted by the Commission's preliminary review of the report(s) referenced above. This notice requests information essential to full public disclosure of your federal election campaign finances. **Failure to adequately respond by the response date noted above could result in an audit or enforcement action.** Additional information is needed for the following item:


-In response to excessive contributions from an individual or committee disclosed on your 2008 September Monthly Report, you state that "In reference to the Commission's letter dated November 26, 2008 referring to the September Monthly Report. A refund of \$550 to Alan Heywood and \$5,000 to National Assn of Realtors will be reflected on the next filing, the January 31st Quarterly report." However, a review of this report does not appear to disclose a disbursement to various organizations (see attached) reported by your committee. Please amend the appropriate report(s) to disclose the disbursement or provide clarifying information regarding this issue. In addition, any refund should be disclosed on Schedule B supporting Line 28(a) and 28(c) respectively, of the report covering the period in which the transaction was made.

Please note, you will not receive an additional notice from the Commission on this matter. Adequate responses must be received by the Commission on or before the due date noted above to be taken into consideration in determining whether audit action will be initiated. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action. **Requests for extensions of time in which to respond will not be considered.**
