Please note that the PAC is aware that we follow an alternate method of itemizing payroll receipts rather than the suggested manner of disclosing a single total for the reporting period along with the amount deducted per pay period. Because the amounts collected per pay period may change often during the time covered by a single report, we find that reporting individual deductions separately more accurately discloses how the receipts are collected.

Earlier this year, CoxPAC discovered that, as a result of an inadvertent processing error, \$7,565.44 in PAC contributions that had been deducted from Cox Communications, Inc. employee paychecks in September 2011 had not been transferred to the PAC and were instead sitting in an account of the PAC's collecting agent, Cox Enterprises Inc. During the current reporting period (April 1 to April 30) and, in accordance with Advisory Opinions 1999-33 (MediaOne PAC) and 2000-11 (Georgia-Pacific), the collecting agent transferred the \$7,565.44 to the PAC. To reflect the fact that these contributions were made in September 2011, the PAC is filing amendments to its 2011 year-end report, and to its 2012 monthly reports from February, March, and April of 2012. These amended reports are being filed concurrently with the PAC's regular May report. Finally, the PAC has taken proactive measures to help prevent similar errors from occurring in the future.
