Dear Treasurer:

Pursuant to 2 U.S.C. §433(d)(2) of the Federal Election Campaign Act, and Commission regulations at 11 CFR §102.4, the Commission intends to administratively terminate your committees (see attached). -The administrative termination of your reporting obligation does not relieve the committee of any legal responsibility for the payment of any outstanding debt or obligation, even if those debts are owed to the United States Department of Treasury.

-The committee must continue to maintain all records in accordance with 2 U.S.C. §432(d) which should be available for Commission inspection should the need arise.

-Any funds used to defray the remaining debts and obligations of the committee must comport with the limitations and prohibitions of the Federal Election Campaign Act of 1971, as amended, and the Commission's regulations.
