Further, 11 CFR §104.18(c) defines report as any statement, designation or report required by the Act to be filed with the Commission. Please provide a complete amended Statement of Organization to disclose the name of your connected organization.
2. Your Amended Statement of Organization (FEC Form 1) was not signed by the individual identified as the current treasurer or designated agent on the form. The treasurer or designated agent must sign the Statement of Organization filed by a committee. Please amend your Statement of Organization to include the appropriate signature. (11 CFR §102.2(a))

Please note, you will not receive an additional notice from the Commission on this matter. Adequate responses must be received by the Commission on or before the due date noted above to be taken into consideration in determining whether audit action will be initiated. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee


