This letter is to clarify the transactions cited in the following reports from your letters dated July 18, 2001:

#### Mid-Year Report (1/1/99 - 6/30/99)

1. Idaho Grain Producers Association, receipts totaling \$3,050. The amounts were incorrectly deposited into our PAC account. These funds were transferred to a non-PAC account on 12/24/99.
2. Montana Grain Growers Association (MGGA), receipts totaling \$1,225. These funds represent individual contributions collected by MGGA. The MGGA served as a collecting agent. No aggregate contributions totaled \$200 or more.

#### Quarterly Report (1/1/00 - 3/31/00)

1. Minnesota Wheat PAC (MNPAC), receipts totaling \$2,500. These funds represent individual contributions collected by MNPAC. The MNPAC served as a collecting agent. No aggregate contributions totaled \$200 or more.

#### Quarterly Report (4/1/00 - 6/30/00)

1. NAWG, disbursement totaling \$3,190. These funds were incorrectly deposited into the PAC account as follows: IGPA, \$3,050 on 1/11/00; John Thaemert, \$50 on 1/18/00; Michael Rick, \$90 on 1/11/00. The funds were transferred to our non-PAC account on 4/5/00.
2. <NONE/UNKNOWN>, receipts totaling \$14,895. The disclosure of these funds is due to a typographical error. This disclosure erroneously aggregated separate individual receipts that fell below the \$200 disclosure threshold. No disclosure should have appeared.
