This letter is sent in response to your letter dated December 30, 2005.

The letter identified three contributions to Victory in November Election PAC (VINE PAC) which appeared to exceed the contribution limits.

Please be advised of the following:

1. The letter identified three contributions to VINE PAC totaling \$12,500. This is incorrect. The contribution made on 4/22/2005 by the California State Pipe Trades Council Voluntary Federal Political Action Fund was \$2,500 and not \$5,000 as stated in the letter.
2. The additional \$5,000 sent by the United Association of Journeymen and Apprentices of the US and Canada Local 447 Federal PAC was sent in error. A refund of \$5,000 from VINE PAC was sent to and received by the Local 447 Federal PAC. Please see filings made by Local 447 on December 20, 2005; reference is also made to the VINE PAC filings.

Based on this corrective action, the amounts contributed to VINE PAC comply with the applicable contribution limit, and no report amendments or further action is required.
