In reviewing the FEC website, I noticed that the FEC website posted a number of political action committee (PAC) contributions that Bart's Bridge PAC DID NOT receive during the July 31 Mid-Year reporting period.

I have double checked, and Bart's Bridge PAC received four (4) PAC contributions during this time period. The PAC contributions to Bart's Bridge were from AMO Retirees Association (1,500), Machinists (5,000), Nurse Anesthetists (2,500) and CMS Energy (500). The FEC website only lists three (3) of these four (4) PACs that contributed to Bart's Bridge PAC. The other 23 PACS listed did not contribute to Bart's Bridge PAC during the July 31 Mid-Year reporting period.
