Dear Mr. Charles:

This letter is prompted by the Commission's preliminary review of the report(s) referenced above. The review raised questions concerning certain information contained in the report(s). An itemization follows:

-Schedule H2 indicates the allocation ratio for the Jefferson Jackson Day Dinner 1998 was revised during the reporting period. Please provide the date on which this revision became effective. In the event that an excessive non-federal transfer was received, the excessive amount should be transferred back to your non-federal account.

-On Schedule H4 supporting Line 21(a) of the Detailed Summary Page, you have failed to include the EVENT YEAR-TO-DATE totals for all payments for fundraising. Please amend your report to include the missing EVENT YEAR-TO-DATE total(s).

-Your report disclosed a category of financial activity that has been reflected on the wrong line of the Detailed Summary Page. Transfers to your non-federal account for a non-federal overpayment of a shared activity should be properly disclosed on a separate Schedule H4, supporting Line 21(a) of the Detailed Summary Page. Please refer to the instructions contained on the forms to determine the proper categorization when preparing your next filing.

A written response or an amendment to your original report(s) correcting the above problem(s) should be filed with the Federal Election Commission within fifteen (15) days of the date of this letter.
