This is a response to the FEC's February 6, 2019 RFAI for Women for American Values and Ethics regarding refund requests for inadvertent excessive contributions.

Women for American Values and Ethics (WAVE), a non-multicandidate committee, inadvertently gave \$5,000 to Harley Rouda for Congress and Katie Porter for Congress during the October 2018 FEC reporting period. WAVE requested a refund of \$2,300 from each campaign committee on February 13, 2019 to correct this situation to the extent possible.

Additionally, WAVE contributed \$5,000 to Mike Levin for Congress on December 6, 2018, as reported on the 2018 Year-End FEC report. WAVE has since requested a refund of \$2,300 from Mike Levin for Congress on February 13, 2019.

Copies of all requests for refunds to each of the three campaign committees are being mailed to the FEC with this response.

WAVE inadvertently gave a contribution of \$5,000 to Harley Rouda for Congress on 8/23/2018 and respectfully requests a refund of \$2,300 to minimize any potential enforcement action by the FEC. WAVE was happy to support Harley Rouda for Congress and looks forward to future opportunities to assist candidates who share WAVE's mission.
