Dear Mr. Walker:

On March 21, 2000, I called you in response to your call to Robert Petersen, Treasurer of the Lincoln Club PAC. You contacted Mr. Petersen because the FEC had not yet received the 1999 year-end PAC 3X report. I advised you that our records show that the PAC 3x report was filed electronically using FEC file on January 28, 2000. You asked that I contact Jeff Chumley at the FEC's Computer Division.

We contacted Mr. Chumley, and he confirmed that the FEC did not receive the 3x report on January 28, 2000, even though our computer produced a "FEC File Validator" (copy enclosed), showing that the data file passed validation, which could not happen at our end if we did not electronically send the file. Mr. Chumley advised us that a filing is not "received" by the FEC until an e-mail confirming receipt and providing a confirmation number is sent to the filer by the FEC. We did not receive this confirmation in January; rather, we thought that the "FEC File Validator" was sufficient proof of the filing.

The electronic filing was attempted again on March 23, 2000; we received a "FEC File Validator" at our end as before, but this time we received an e-mail confirmation from the FEC. The Lincoln Club 3X report should now be on file.
