- It has come to the attention of the Federal Election Commission that the reports you have filed during the current election cycle do not reflect the appropriate coverage dates for quarterly filing status. Please be advised of the filing dates and coverage periods for the 2015-2016 election cycle and fill in the appropriate dates on Line 5 of the Summary Page. For your information and consideration when preparing future filing, refer to the schedule provided for your next filing. (52 U.S.C. §30104(a) (formerly 2 U.S.C. 434(a)) and 11 CFR §104.5(c))

Please note, you will not receive an additional notice from the Commission on this matter. Adequate responses must be received by the Commission on or before the due date noted above to be taken into consideration in determining whether audit action will be initiated. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to
