This correspondence is in response to your October 13, 2000 letter to Mitchell Kane, Treasurer of the Glaxo Wellcome, Inc. PAC, regarding the reporting of a debt retirement contribution.

In May of this year, the Glaxo Wellcome PAC made a \$1000 contribution to the Kellemis for Congress campaign committee. At the time, the Committee told us that Mr. Kellemis had campaign debt and so we designated the money for debt retirement. However, your recent correspondence notified us that Mr. Kellemis has not reported any campaign debt to date. According to our records, check #7981 dated 5/8/2000 in the amount of \$1000 payable to Kellemis for Congress has not been cashed hence, we have arranged a stop payment on this check to comply with FEC regulations. The cancellation of the contribution will be properly disclosed on our next FEC report.
