Dear Ms. DeCarmine,

This is in response to your letter dated March 4, 2009, with code RQ-2.

First, I apologize for the error on the report as filed. It was a matter of failing to copy two numbers from my worksheet onto the final form that I filed. With the exception of those two uncopied numbers, all of the other information on the form as submitted was correct, including numbers that were derived from the "ghost" or "missing" numbers.

Specifically, the missing totals for Line 7, Columns A and B of the Summary Page are shown on the attached copy of page 2 of the report, with the correct numbers shown in red. These numbers are, in fact, identical to the numbers shown on Line 31 of the form as originally submitted (as they should have been.) With the numbers now filled in on line 7, rather than being "ghost" numbers, the derived totals on line 8 as originally submitted now make sense.

I wish to also assure you that the correct numbers (as now shown in red on the attached page) were used as the starting numbers in my subsequent report for calendar year 2008, so no other errors are apparent to me beyond this simple error of failing to transfer these 2 numbers from my worksheet to the final form.

I have been attempting to reach you by phone to verify if this format of submitting a response is the correct format, but we have been exchanging voice mails and I wanted to get this response in well before the deadline. If more information is needed from me, or information in a different format, please let me know. If the phone tag continues, and if it is possible, could you leave me a detailed message of what I should do – rather than simply asking for a return call.

Thanks for your understanding in this matter, and again my apologies for my carelessness in failing to copy those two numbers.
