Dear Mr. Whyrick,

We have been retained by National Organization for Marriage ("NOM") to respond to the Request for Additional Information dated January 2, 2013. Please accept this letter as an adequate response.

A 48-hour notice was timely filed for the independent expenditure made by NOM on August 24, 2012. On that date, NOM contracted with Mission Public Affairs to make a radio ad buy. The ads aired from August 27 through September 2, 2012, as noted in the "Purpose of Expenditure" section of the 48-hour notices filed. An invoice was provided the same day, August 24, for \$34,000. A 48-hour notice was filed electronically on August 25, 2012, with this amount. NOM was subsequently provided with a revised invoice on August 27, 2012, that included production costs, which were not originally included. An amendment to the 48-hour notice was promptly filed on August 27, 2012, with the new total of \$38,700. The October Quarterly Form 5 report, however, only lists the most recent amended report, so It looks like the expenditure was made on August 24, 2012, and the 48-hour notice not filed until August 27, 2012. Nevertheless, as explained above, a 48-hour report was timely filed. Copies of the 48-hour notices are attached for your convenience.
