- Your calculations for Line 19, Column B appear to be incorrect. Please provide the corrected total(s) on the Detailed Summary Page.
- Your calculations for Line 20, Columns A and B appear to be incorrect. Please provide the corrected total(s) on the Detailed Summary Page.
- Your report discloses no payments for administrative expenses. Each committee utilizing separate federal and non-federal accounts is required to allocate any administrative expenses between the accounts in proportion to the BALLOT COMPOSITION METHOD derived from FEC Schedule H1. A Schedule H1 must be filed with the first FEC FORM 3X file at the beginning of each two-year election cycle. 11 CFR §106.5(d)

If your committee has only one account, the total operating expenditures (administrative expenses) should be reported on Line 21(b). Please amend your report to confirm the nature of your expenditures and to provide the total on the appropriate line.

-Be advised that you have used an incorrect committee identification number on the Summary Page of your report(s). Please file all future reports and correspondence using your correct identification number, C00000992, to avoid potential errors in entering your reports onto the public record.

-Please provide the complete coverage dates of your report on Line 5 of the Summary Page.

A written response or an amendment to your original report(s) correcting the above problem(s) should be filed with the Federal Election Commission within fifteen (15) days of the date of this letter.
