On December 11, 2002, you were notified that a review of the above-referenced report(s) raised questions as to specific contributions and/or expenditures, and the reporting of certain information required by the Federal Election Campaign Act.

Your December 18, 2002 response is incomplete because you have not provided all the requested information. For this response to be considered adequate, the following information is still required.


- The Commission is in receipt of your Amended July Quarterly Report dated December 18, 2002 and the memo text you provided at the end of this report regarding the \$5,000 contribution to the John Cornyn for Senate, Inc. The memo text indicates "the \$5,000 contribution dated June 13, 2002 was for the general election. We have made these corrections in this amended report."

Upon review of Schedule B supporting Line 23 of this report, the contribution to John Cornyn for Senate, Inc. for \$5,000 (pertinent portion(s) attached) discloses the original designation of primary debt retirement. Please be advised that the actual Schedule B supporting Line 23 must be corrected to reflect the correct designation as indicated in your memo text for the public record. Please amend this report in order to accurately reflect the corrective action taken by your committee.

An adequate response must be received at the Commission by March 5, 2003. Adequate responses received on or before this date will be taken into consideration in determining whether audit action will be initiated. **Requests for extensions of time in which to respond will not be considered.** Failure to provide an adequate response by this date may result in an audit of the committee. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action.

Electronic filers must file amendments (to include statements, designations and reports) in an electronic format and must submit an amended report in its entirety, rather than just those portions of the report that are being amended.
