This responds to your letter concerning the above referenced FEC report.

Please be advised that the payment received from "Montanans for Tester" and reported on Schedule A supporting Line 15, represents the actual costs for the personnel services provided.

We have amended our Post-General Report to include a list of the committees designating the Democratic Senatorial Campaign Committee to make coordinated expenditures. We have also amended the Post General Report, Schedule F, supporting Line 25, to provide the actual date the expenditure was incurred, where payment was made after the general election date. 

