Dear Ms. Grant,

The amended reports reflect changes to two reports that affected the Election Cycle-to-Date totals in the Pre-Primary report.

One contribution was originally assigned and allocated incorrectly affecting the itemization line total but not the cash on hand. This was caught and corrected between the filing periods for the July Quarterly and the Pre-Primary, causing the Pre-Primary report Election Cycle-to-Date totals to differ from the July Quarterly report totals.

In that same time period, a memo entry for \$40 was also discovered to have been double reported. This was also corrected after the July Quarterly was filed but before the Pre-Primary report was filed, again causing the Pre-Primary to differ from the July Quarterly.

These amendments carry those updates through all the reports so the Election Cycle-to-Date columns are now amended and corrected.





