
While we were in the process of responding to your letter dated June 17, 1998, we received the enclosed letter and check from Citizens for Arlen Specter. The committee refunded the \$2,000 in excess of the federal limitation for donations by a non-multicandidate political committee to a federal campaign candidate. We are currently reviewing our records to determine if we qualify as a multi-candidate political committee. In the event that our organization does qualify as a multicandidate political committee, we will provide your office with the necessary documentation.

Our accountant is currently preparing a response to your question about our administrative expenses and she will also be responding to your letter dated June 19, 1998. She is in the process of revising the schedules and will forward them to your office by July 20, 1998.

On behalf of Senator Specter, I want to thank you for your generous financial contribution to Citizens for Arlen Specter. Your gift has been put directly to work funding vital campaign projects.

Federal law allows individuals and political party organizations to contribute \$1,000 towards the Primary election and \$1,000 towards the General election for a total of \$2,000 per person or organization.

Our records indicate that your PAC is not a federal multi-candidate PAC and therefore subject to the limits of a political party organization. We must return \$2,000 of your primary contribution because the limit on re-designation has run out.

However, you are still eligible to contribute \$1,000 to the Senator's general election campaign.
