Dear Mr. Ng,

Pursuant to our conversation please be advised that Plumbers Local Union No. 1, U.A. of New York City will amend all contributions which exceed the limits set forth in Act. 2 U.S.C. 441a(a) in regards to the Congressional Campaign of Anthony Weiner.

Please be advised that Mr. Weiner ran a primary and general election campaign on both the Democratic and Independent Party lines, therefore setting the contribution limit at \$10,000.00.

We unknowingly donated in excess of the permitted limit due to the fact that we were not aware of Plumbers and Pipefitters Local 9 Political Action Committee donation of \$4000.00.

It is our understanding that we are \$1,750.00 over the permitted limit allowed to be contributed to this campaign. Therefore we will direct "The Friends of Weiner" campaign committee to reallocate \$1,750.00 of the \$2000.00 donation made on September 1, 1998 to his newly authorized committee "Friends of Weiner 2000", in order to put us in compliance with the law. All proper Amendments will filed in a timely manner.
