This memorandum is being sent as an attachment to our July 15, 2006 filing with your office, pursuant to a telephone call to your office on July 10, 2006 regarding this matter. An analyst, Katrina, advised submittal of this memorandum.

The reason for the telephone call was our discovery that four checks deposited in our Federal Political Action Account (HCA FedPAC) were submitted by corporate entities. Attempts with our bank to have the deposits held up to correct the matter were unsuccessful. The receipts listed in line 6 (c) of the report contain \$3,150 in disallowed contributions from four entities.

To correct this matter, the HCA FedPAC will issue reimbursement checks to each of the entities. These transactions will be detailed in our next, required report with your office. We hope this will correct this problem.


