

Dear Mr. Ryan:

This letter responds to a letter dated February 5, 1998, from Mr. John D. Gibson, Assistant Staff Director, Reports Analysis Division, Federal Election Commission, concerning the above-referenced report.

In his letter, Mr. Gibson indicated that OBA Fed Elect needed to provide "complete information regarding" CPAC, from whom a contribution of \$800 was received.

CPAC is a state political action committee registered with the Oklahoma Ethics Commission. No corporate funds or other funds prohibited by federal law and Federal Election Commission rules were included in the CPAC contribution, as Oklahoma state law closely parallels federal law in that regard. We believe, therefore, that the contribution was lawful.

However, as a matter of convenience and to assure compliance with the Federal Election Campaign Act and FEC rules, we have transferred the \$800 donation to a state political action committee affiliated with the Oklahoma Bankers Association.

The transfer will be reflected in our next report to the FEC.

Please let us know if this action is inappropriate, or if we need to take other steps. Thank you for your consideration and cooperation.


