7/1/98-9/30/98.


We have adjusted the items mentioned in your letter. The errors

in our first Report of the year. In fact, our participation was too
late to encourage the registering of voters. We could only contribute
to committees who had or were setting up phone banks to phone registered
voters urging them to go to the polls and vote.
