Thank you for your letter of July 20, 1994 advising me that the proposed name of the Apartment and Office Building Association of Metropolitan Washington, D.C. Political Action Committee (Metro PAC-Federal) was not in compliance with 2 U.S.C., Section 432 (e) (5).

The omission of the connected organization's name -- Apartment and Office Building Association of Metropolitan Washington, D.C., Inc. -- was an oversight on our part and partially a result of the limited space under item 1 (a) of FEC Form 1. Consequently, I am enclosing an amended FEC Form 1 to correct that oversight as well as to correct the inadvertent emission of the incorporated status of our organization under the box for the name of the connected organization.

I trust that the above actions will bring our statement of organization into full compliance with statutory requirements.
