Kimberly did not clearly understand that she had to take further steps after she imported the information into her FEC file software in order to properly show the non federal portion of the disbursements and the receipts paid by the non federal account. As soon as Kimberly was made aware of the omission she immediately corrected any reports that did not properly disclose allocable expenses. All reports going forward will correctly disclose allocable expenses. The additional disbursements and receipts did not adjust the Cash on Hand balance as it was the regular practice of the IDP to exactly match the non-federal portion of expenditures on a regular basis.
