
Consistent with our previous conversations by telephone, please be informed that I am terminating my relationship with the RUSS FOR CONGRESS campaign committee and Democrat Russell L. Gottesman's campaign for the House of Representative's in Ohio's 10th Congressional District.

I am terminating my role as both Assistant Treasurer and Custodian of Records for the RUSS FOR CONGRESS campaign committee.

Because the campaign committee has not been responsive to my notice that I would be terminating my relationship with the campaign, and because I consider myself to now be the *former* Assistant Treasurer for the RUSS FOR CONGRESS campaign committee, I do not believe it is proper for me to file an appended FEC FORM 2 to formally remove myself as Assistant Treasurer and to designate a new Custodian of Records.
