
I am writing in response to your letter of April 22, 1998, Mr. John Gibson's letter of May 20, 1998 and our subsequent conversations regarding IADLC's Year End Report (7/1/97 - 12/31/97).

This letter is accompanied by IADLC's amended Year End Report within which the following notes and changes have been made regarding the questions raised in your letter:

1. The address for each disbursement itemized on Schedule B are included on the original report. The full address is given the first time a recipient is entered but not repeated on subsequent entries.
2. The "Salute to the Italian American Democratic Members of Congress" is the event (only event) reported on schedules H2, H3 and H4. I have titled it Event #1 on all three schedules in the amended reports.
3. The total Event Year-to-Date amounts have been entered on the amended Schedule H4.
4. All administrative expenses incurred by IADLC for its operation have been disclosed in our report. IADLC has not reported rent or utilities expenses because we do not occupy a space and operate mainly by telephone and through the use of consultants.
