This letter is intended to supplement the Q42015 / Krang Eng Report for Wes NEUMAN FOR CONGRESS, a political campaign committee (FEC Identification Number C00553545), which has also been submitted today, January 15, 2016.

In October 2015, a representative from the FEC informed this campaign that, due to an ongoing, unambiguously partisan investigation, it was not feasible to formally for the agency to formally acknowledge termination of the campaign. The FEC subsequently instructed this campaign to continue filing quarterly reports in accordance with the law.

The FEC also told this campaign that, given the unambiguous inactivity, the only change in the new report submitted would be the period of time (e.g., October 1, 2015, through December 31, 2015, or Q4, instead of July 1, 2015, through September 30, 2015, or Q3). This campaign has long since terminated its bank account and ceased fundraising; it has no resources, financial or otherwise, involved in any political, electioneering, and/or other activities.

Accordingly, this campaign committee continues to demonstrate it is inactive by having no contributions, no expenditures, no transfers, no loans, no refunds or no other disbursements of any kind (e.g., labor, marketing *etc.*). Total, gross, and/ or net financial activity remains \$0.00.

As all correspondence to the Federal Election Commission is public record, this letter is to genuinely and publicly reflect that this campaign has been – and shall remain – entirely shut down, *sine qua non* the FEC being unable to formally acknowledge its termination. Thank you.


