This is in response to your letter dated September 19, 2001 concerning the Year End Report (11/28/2000 - 12/31/2000) of the above referenced Committee.

We will amend the report to fulfill your questions. The amendment will follow this correspondence under separate cover.

1. A total will be provided for Line 11(a)(iii), Column B of the Detailed Summary Page.
2. Schedule A will be provided to support the entry disclosed on Line 11(c) of the Detailed Summary Page.
3. The addresses and purposes for each disbursement itemized on Schedule H4 will be provided.
4. Schedule H4 supporting Line 21(a) of the Detailed Summary Page will include the total Event Year-to-Date amounts paid to all payees.

You have also asked about the committee's administrative expenses. The Prairie Leadership Committee is a small committee that has few administrative expenses. The Committee has no rented office space and depends on its paid staff and volunteers to administer its limited activities. All of the expenses incurred to operate the Committee have been reported on our FEC reports.

Regarding the transfers for joint federal and non-federal activity: Even though the transfers you refer to were made in the year-end reporting period, the allowed 90-day time period covers disbursements for joint activity that were paid to vendors in November 2000 and therefore were disclosed on the Committee's Post-General report.
