In response to your letter dated October 22, 1997, I am enclosing the amended FEC Report per your request correcting:


*Line 11(a)(iii) Columns A and B

Regarding our exceeding the limits set forth in the Act, 2 U.S.C 441a(a) to Senator Coverdell, we have enclosed copies of the five checks made payable to "Coverdell Good Government Committee." Check #1228 dated March 29, 1993 for \$1,000 had "General Election" typed on it whereas the other four checks did not. A clerical error was made pertaining to these four checks. They were designated on the FEC reports as going to the "general" election whereas they should have gone to the "primary" election. Thus, \$1,000 has been contributed to Senator Coverdell's "general" election as evidenced by check #1228 in 1993 and the other four checks for a total of \$4,500 have been contributed to the Senator's "primary" election. As you have requested, we have corrected these four entries on our revised FEC report to reflect their designation as "primary" election.

I hope these actions rectify the aforementioned items. Please let us know if there is anything else we need to do.

Dear Mr. Abenante:

This letter is prompted by the Commission's preliminary review of the report(s) referenced above. The review raised questions concerning certain information contained in the report(s). An itemization follows:

-Your calculations for Line 11(a)(iii), Columns A and B appear to be incorrect. FEC calculations disclose this amount(s) to be \$17,250. Please provide the corrected total(s) on the Detailed Summary Page.

-Line 23 of the Detailed Summary Page of your report discloses a total of (\$2,500) in contributions to federal candidates. The sum of the entries itemized on Schedule B, however, indicates the total to be \$6,500. Please amend your report to clarify the discrepancy.

-Line 21(a) of the Detailed Summary Page should only be used to report the federal and non-federal shares of allocable activities. If your committee has only one account, the total operating expenditures (administrative expenses) should be reported on Line 21(b). Please amend your report to confirm the nature of your expenditures and to provide the total on the appropriate line.

-Schedule B of your report (pertinent portion(s) attached) discloses a contribution(s) which appears to exceed the limits set forth in the Act. 2 U.S.C. §441a(a) precludes a multicandidate committee and its affiliates from making a contribution to a candidate for federal office in excess of \$5,000 per election.

If the contribution(s) in question was incompletely or incorrectly disclosed, you should amend your original report with clarifying information. If you have made an excessive contribution, you should notify the recipient and request a refund of the amount in excess of \$5,000 and/or notify the recipient in writing of your redesignation of the contribution. In the best interest of your committee, all refunds and redesignations should be made within sixty days of the treasurer's receipt of the contribution(s).
