
Dear Ms. Bacon



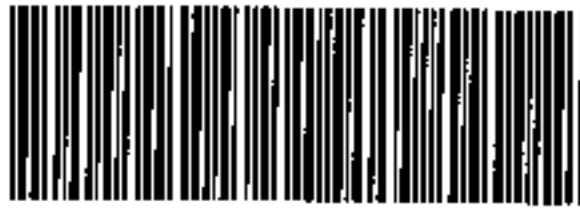
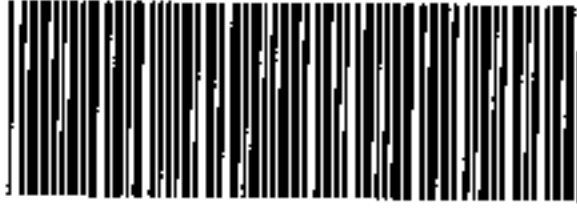
