The cost to the organization is then determined by the number of records requested and the length of time access will be granted. i.e. Statewide or congressional charges are based on the number of records in the district or entire state as requested. - Please note that the employees that were disclosed on Schedule H4 supporting Line 21(a) as payroll spent less than 25% of their time during the period working on any Federal Election Activity or activities in connection with a Federal Election therefore salary payments were allocable. This also includes fringe benefits for those specific employees.
