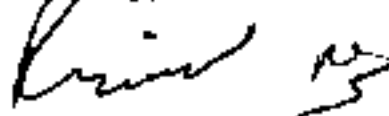
This letter is prompted by the Commission's preliminary review of the report(s) referenced above. The review raised questions concerning certain information contained in the report(s). An itemization follows:

- Line 23 of the Detailed Summary Page of your report discloses a total of -\$1,364.88 in contributions. The sum of the entries itemized on Schedule B, however, indicates the total to be \$2,135.12. Please amend your report to clarify the discrepancy.
- Your report includes a memo disbursement schedule indicating a voided disbursement total of (\$25,500). However, Schedule B supporting Line 23 of the Detailed Summary Page indicates a voided disbursement total of -\$22,000. Please amend your report to clarify this discrepancy.

A written response or an amendment to your original report(s) correcting the above problem(s) should be filed with the Federal Election Commission within fifteen (15) days
