Dear Mr. Furman,

This statement is in response to the Commission's letter to the Committee dated November 19, 2020, regarding certain contributions disclosed on the above-referenced report ('the Original Report') that appeared to exceed federal contribution limits. As described below, all of the contributions identified in the Commission's letter were properly and timely redesignated, reattributed, refunded/charged back, or returned to a joint fundraising committee ('JFC') in which the Committee participates for proper reallocation, as is or will be reflected on either (as appropriate) the Amended Report being filed contemporaneously with this submission or on a subsequent Committee Report.

First, the Commission's letter requests clarification on contributions from five federal committees disclosed on the Original Report. With respect to those contributions:

- The contributions from the Tennessee Republican Party Federal Election Account identified in the Commission's letter were received through a distribution from Trump Make America Great Again Committee (C00618371), JFC in which the Committee participates. The contribution from Accountability PAC identified in the Commission's letter was received through a distribution from Trump Victory (C00618389), another JFC in which the Committee participates. Any funds received through a JFC distribution that resulted in an excessive contribution have been returned to the JFC for reallocation among participants in accordance with the allocation formula set forth in the governing joint fundraising agreement. The reallocations will be disclosed by the relevant JFC on the appropriate report.
- The contribution from Elbert Guillory's America received on August 27, 2020; the contribution from Americans for Legislating Excellence PAC received on August 26, 2020; and the contribution from Friends of Glenn Thompson received on August 26, 2020, all were properly designated to the Committee's 2020 general election account.

Second, the Commission's letter requests clarification on contributions from 1,684 contributors disclosed on the Original Report. With respect to those contributions:

- 1,113 of the listed contributors' contributions were redesignated to another election.
- 192 of the listed contributors' contributions were either refunded or charged back to the contributor's credit card.
- 47 of the listed contributors' contributions were made by contributors who had contributed to the Committee but subsequently made additional contributions to either Trump Victory (C00618389) or Trump Make America Great Again Committee (C00618371), which distributed the contributions to the Committee. Any funds received through a JFC distribution that resulted in an excessive contribution have been returned to the JFC for reallocation among participants in accordance with the allocation formula set forth in the governing joint fundraising agreement. The reallocations will be disclosed by the relevant JFC on the appropriate report.
- 332 of the listed contributors' contributions were in part (i) redesignated to another election and (ii) either (a) refunded or (b) returned to the JFC that transferred the contributions to the Committee to be reallocated by that JFC among its participants in accordance with the allocation formula set forth in the governing joint fundraising agreement.
