Dear Treasurer:

This letter is prompted by the Commission's preliminary review of the report referenced above. This notice requests information essential to full public disclosure of your federal election campaign finances. **Failure to adequately respond by the response date noted above could result in an audit or enforcement action.** Additional information is needed for the following 1 item(s):

- Schedule B of your report discloses a payment of \$52,851.89 to NY Fairness PAC on 9/11/19 with the purpose "Travel Expenses, Digital Advertising, Rent."

NY Fairness PAC appears to be a committee established by the candidate for a non-federal election campaign. Contributions and/or transfers from a candidate's nonfederal committee to his or her federal committee are prohibited. (11 CFR § 110.3(d))

If the Committee received a prohibited contribution/transfer, a refund must have been made within 30 days of the treasurer becoming aware of the illegality of the contribution/transfer. (11 CFR § 103.3(b)(2)) The Commission notes your explanation regarding the committee's corrective action taken for this apparent prohibited contribution/transfer. If any apparently prohibited contribution/transfer was incompletely or incorrectly disclosed, you must amend your original report with the clarifying information.

Although the Commission may take further legal action, your prompt action to refund the prohibited amount will be taken into consideration.

Please note, you will not receive an additional notice from the Commission on this matter. Adequate responses must be received by the Commission on or before the due date noted above to be taken into consideration in determining whether audit action will be initiated. Failure to comply with the provisions of the Act may also result in an



enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action. **Requests for extensions of time in which to respond will not be considered.**

Electronic filers must file amendments (to include statements, designations and reports) in an electronic format and must submit an amended report in its entirety, rather than just those portions of the report that are being amended.
