
Line 21b, Schedule B shows all of the expenditures, including any administrative expenses, for the Northwest Leadership PAC for each of the periods indicated. We are a new PAC with limited activities, so the work is done out of my home, with no rent or operational activities beyond the expenses detailed in the reports. Salary amounts are based on quarterly amounts and shown at time of payment.

April quarterly report (1/1/98-3/31/98)

Schedule B, line 23, shows a \$5000 contribution to a Congressional candidate, falling under our interpretation that we were a qualified multi-candidate committee. Seven months prior to the contribution, we had satisfied the requirements of being a multi-candidate committee; a.) been a committee for over six months; b.) contributed to 5 federal candidates; and c.) had over 50 contributors to the committee. Upon talking with FEC Reports Analyst, Andrea Wilkens, she informed me that we needed to have a FEC Form 1M on record. Enclosed is the form she sent me verifying the date of qualification.
