This amendment is in reference to the RFAI dated October 12, 2016, see below for our complete response. 1. We are aware of the contribution limits for donors to our committee. The contributions in question were temporarily excessive pending authorization of re-attribution to a spouse. Only one of these authorizations was received and re-attributed. This re-attribution was shown on the October quarterly report. The other excessive contributions were refunded. These refunds were reported on the October quarterly and Pre-General reports. 2.The contribution from American College of Cardiology PAC was designated for the 2016 Primary election as it was mailed to the committee and postmarked prior to the primary election date. A copy of this envelope showing the postmark date has been retained for the committee's records. The postmark date was noted using memo text on the July quarterly report. The contributions from American Physical Therapy Association Physical Therapy PAC and TrueBlue Inc. PAC were designated to Primary and received after the Primary date. These have been refunded. The refunds will be shown on the upcoming Post-General report. 3.The 3/3/16 contribution from John Madigan was originally reported for General 2016 in error. The contribution was received prior to the Primary 2016 election date and reattributed to his spouse, Holly Madigan, within 60 days of receipt. We have amended the April quarterly report to correctly designate his original contribution.
