- Line 5(d) indicates that your committee is a subordinate party committee. However, the Statement of Candidacy filed by "Kellie Collins" designates your committee as the candidate's Principal Campaign Committee.

Please be advised that a Principal Campaign Committee is a political committee designated and authorized by a candidate to receive contributions and make expenditures on the candidate's behalf. (§100.5(e)(1))

If your committee is a Principal Campaign Committee, an amended Statement of Organization should be submitted which indicates the appropriate Type of committee on Line 5(a).

If your committee is not a Principal Campaign Committee, you must amend your Statement of Organization to change the name of your political committee so that it does not include the name of a federal candidate. (52 U.S.C. §30102(e)(4) (formerly 2 U.S.C. §432(e)(4)) and 11 CFR §102.14)

Please note, you will not receive an additional notice from the Commission on this matter. Adequate responses must be received by the Commission on or before the due date noted above to be taken into consideration in determining whether audit action will be initiated. Failure to comply with the provisions of the Act may also result in an

enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action. **Requests for extensions of time in which to respond will not be considered.**

Electronic filers must file amendments (to include statements, designations and reports) in an electronic format and must submit an amended report in its entirety, rather than just those portions of the report that are being amended.
