

This letter is to inform you that on Saturday, 20 November, 2004, the America First Party of Colorado held its annual convention. At that meeting, Anne O'Brien tendered her resignation from the office of Treasurer of the America First Party of Colorado.

Following the close of the convention, the executive committee met and appointed me to serve as interim Treasurer until the position can be filled by election at a state meeting or convention of the Party.


