This amendment has been filed because the transaction with Winthrop & Weinstine, PA PAC was inadvertently reported on line 23 and itemized on page 43 in our compliance software. It was a refund of a contribution and is now on line 28C and itemized on page 44. The party paid for all volunteer materials with its own funds. No funds from National Party Transfers were used in association with these activities. Disbursements itemized on Schedule B, line 21b relate to individuals that are paid 100% federal but not currently involved in federal election activity. Disbursements itemized on Schedule H4, Line 21a relate to individuals who spend more than 0% but less than 25% in a given month on any federal activity. Disbursements itemized on Schedule B, line 30 relate to individuals who spend more than 25% on federal election activity. All related expenses are apportioned accordingly.
