By taking this action, I understand and agree that I will not run as a write-in candidate for this office, that I am ineligible to receive a certificate of election for this office, and that I will not seek, hold, or accept election or appointment to this office. Further, I request and agree that the State of Arizona and Pima, Pinal, Cochise, Santa Cruz County:

1. Will not print my name on the ballot for this office;
2. Will not count or tabulate any votes which may be cast for me for this office;
3. Will not include my name in the election canvass for this office, nor issue me a certificate of election for this office.
