Dear Candidate:

This letter constitutes formal written notification that Bernard Fontaine Campaign has filed reports of receipts and disbursements with the Commission and appears to have received contributions and/or made expenditures in support of your 2014 candidacy in excess of \$5,000. (11 CFR § 100.3(a))

You have thirty-five (35) days from receipt of this notification to disavow these activities. To disavow send a letter directly to the Commission, marked Attention: Reports Analysis Division, stating that you are not a candidate for Federal Office and that you have not authorized the solicitation of contributions nor the making of expenditures on your behalf.

If you do not disavow these activities, you should file a Statement of Candidacy (FEC FORM 2). The FEC FORM 2 can be downloaded from the FEC website at <http://www.fec.gov>, or requested through the FEC Faxline at (202) 501-3413. (11 CFR § 101.1(a))

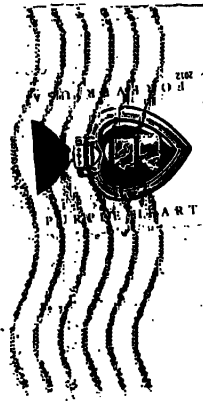

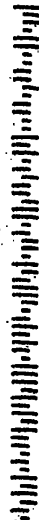
