Plans changed at the last minute and she did not attend the conference. This is reimbursing the PAC for the money paid for the conference (\$795 was reimbursed from the Political Affairs Council) and travel (\$1,127 for a fully refundable airline ticket). Both amounts were purchased with the consultant's credit card months in advance and had already been reimbursed to Enzi Strategies, LLC from the PAC. This reimbursement back to MBE PAC is from Enzi Strategies and is not a corporate contribution. It is only a reimbursement for expenses.
