Dear Candidate:

This letter constitutes formal written notification that Culp 4 Senate has filed reports of receipts and disbursements with the Commission and appears to have received contributions and/or made expenditures in support of your 2010 candidacy in excess of \$5,000. - After written notification by the Commission that any other person has received contributions aggregating in excess of \$5,000 or made expenditures aggregating in excess of \$5,000 on the individual's behalf, the individual fails to disavow such activity by letter to the Commission within 30 days receipt of the notification." (11 CFR § 100.3(a))

You have thirty-five (35) days from receipt of this notification to disavow these activities. To disavow send a letter directly to the Commission, marked Attention: Reports Analysis Division, stating that you are not a candidate for Federal Office and that you have not authorized the solicitation of contributions nor the making of expenditures on your behalf.
