Dear Ms. Mongeon:

This statement is in response to the Commission's letter dated January 10, 2017 regarding eleven items.

First, any anonymous contributions exceeding \$50 have been disgorged to a charity. This disgorgement will appear on the appropriate report.

Second, with respect to the non-federal committees listed, our Committee has safeguards in place to ensure these committees used federally permissible funds for their contributions. After research, the Committee has confirmed that these non-federal committees used federally permissible funds. In addition, any excessive contributions have been refunded and will be disclosed on the appropriate report.

Third, the contributions from the corporations listed on the Commission's letter were contributed via a joint fundraising committee, Trump Make America Great Again (C00618371). The contributions from the corporations have been returned to that committee to be refunded, and that committee will disclose the contribution refunds on the appropriate report. The transfer of those funds from Donald J. Trump for President, Inc. to Trump Make America Great Again will also be reflected on a subsequent report.

Fourth, regarding contributions from LLCs (limited liability companies), our Committee has safeguards in place to ensure that all contributions are made by eligible contributors only. Twenty-eight of the contributions listed on the Commission's letter were contributed via a joint fundraising committee, Trump Make America Great Again (C00618371). These 28 contributions have been returned to that committee to be refunded, and that committee will disclose the contribution refunds on the appropriate report. The transfer of those funds from Donald J. Trump for President, Inc. to Trump Make America Great Again will also be reflected on a subsequent report. We have confirmed that the remainder of the LLC contributions referenced in your letter were made with federally permissible funds. Partnership attributions have been included on the Amended report.

Fifth, you requested clarification on contributions that appear to exceed federal limits. Three hundred ninety-six of the contributions have been refunded and these refunds will be reflected on the appropriate report. The remaining 1,050 contributions were from contributors who had previously contributed to the Committee, and made additional contributions via Trump Victory (C00618389) or Trump Make America Great Again (C00618371), two joint fundraising committees in which the Committee participates. Any excessive contributions that resulted from contributions to one or both JFCs and allocated to the Committee have been returned to the relevant joint fundraising committee for proper reallocation, and will be disclosed by the relevant joint fundraising committee on the appropriate report.

Sixth, the contributions listed on the attachment to the Commission's letter dated 10/20/2016 (Bragan to Walker), were a part of a joint fundraising committee distribution (Trump Make America Great Again (C00618371)) that occurred on 10/21/2016. These contributions were properly reported on the 48 Hour Report filed on 10/23/2016. The contributions listed on the attachment to the Commission's letter dated 10/24/2016 (Abma to Wilsey) were properly reported on the 48 Hour Report filed on 10/25/2016. Finally, the remainder of contributions listed on the attachment to the Commission's letter (Jacobs to Schutter) were transfers received as part of a joint fundraising committee distribution (Trump Make America Great Again (C00618371)) that occurred on 11/8/2016. Due to an inadvertent clerical error, the transfer date reported to the Commission (11/4/2016) was incorrect. Since the contributions were received on 11/8/2016, outside the 48 Hour reporting period, no 48 Hour notice was required. The report has been amended to reflect the correct transfer date.

Seventh, the Committee did not file any duplicate 48 Hour Notices. Upon review, we have determined that, due to an inadvertent clerical error, an in-kind contribution was reported with an incorrect date on Schedule A. The date of the in-kind contribution has been corrected on the Amended report being filed concurrently with this response.

Eighth, the contributions that were reported on 48 Hour Notices but did not appear on the Committee's Schedule A-P constituted JFC memo entries that were inadvertently not uploaded due to a clerical error. These memo entries have been included on the Amended report being filed concurrently with this response. Cash on hand is not affected.

Ninth, the contribution refund issued to Kayla Hensley was issued in error. The refund was voided and this will be reflected on the appropriate report. The contribution refund to Clint Urso includes a refund for several contributions. The report will be amended to clarify the appropriate election designations.

Tenth, to the best of the committee's knowledge, the contributions disclosed in Line 17(a)(ii) of the Detailed Summary Page consist of contributions from contributors that do not exceed \$200 in aggregate for the election cycle. The Committee conducts continued and routine donor record maintenance. If during this routine record donor maintenance, the Committee identifies and merges the records of duplicate donors to reflect proper aggregates, the Committee will amend its report.

Eleventh, the difference between the amount transferred from Trump Make America Great Again (C00618371) and the individual memo entries supporting the transfer constitute unitemized contributions. To the best of the Committee's knowledge, none of the unitemized contributors exceeded \$200 in aggregate for the election cycle. The Committee conducts continued and routine donor record maintenance. If during this routine record donor maintenance, the Committee identifies and merges the records of duplicate donors to reflect proper aggregates, the Committee will amend its report.

Additionally, the missing election designations for contributions disclosed on Schedule A-P for Line 18 have been supplied on the amended report being filed concurrently with this response.
