This amendment is being submitted to provide the FEC with notice that America's Promise, FEC ID# C00781385, intends to change its designation from an independent expenditure-only committee (Super PAC) to a Hybrid PAC effective September 24, 2021. Consistent with the stipulated judgment in Carey v. FEC, this committee intends to establish a separate bank account to deposit and withdraw funds raised in unlimited amounts from individuals, corporations, labor organizations, and/or other political committees. The funds maintained in this separate account will not be used to make contributions, whether direct, in-kind, or via coordinated communications, or coordinated expenditures, to federal candidates or committees.
