Dear Mr. Braithwait:

On June 5, 1996 you were notified that a review of the above-referenced report(s) raised questions as to specific contributions and/or expenditures, and the reporting of certain information required by the Federal Election Campaign Act.

Your June 19, 1996 response is incomplete because you have not provided all the requested information. For this response to be considered adequate, the following information is still required.

-The Commission notes the receipt of your amended reports disclosing the intended election designation for two contributions totalling \$6,000 to the Wellstone for Senate committee. It appears however, that an excessive of \$1,500 for the Primary election still remains. Attached for your review are the Schedule B(s) enclosed with our previous letter and the amended Schedule B(s) submitted with your response. If the contributions in question were incompletely or incorrectly disclosed, you should amend your original report with clarifying information. Any redesignations should be disclosed as memo entries on Schedule B supporting Line 23 of the report covering the period during which the redesignations are made.

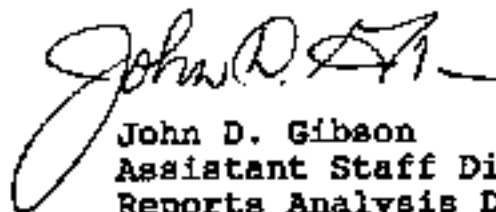
If this information is not received by the Commission within fifteen (15) days from the date of this notice, the Commission may choose to initiate audit or legal enforcement action.
