Apparently, we had a third party file an FEC-2 but they did so for a Committee that they created on my behalf (my signature is on it, so I accept responsibility).

This came to light during my conversation with Chris Jones (in one of your departments) and he recommended that I send you a FEC-2 for the right committee and ask that you completely close out any reference to the additional one that was created (although he said it doesn't "technically exist" because they never filed a FEC-1).

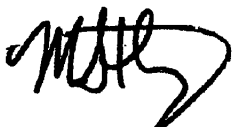
Hopefully this makes sense to you – I think I've explained it as best as I know how.

I APOLOGIZE for the confusion – and if there's any points that need to be clarified, please feel free to call me at the # above (it is direct/cell).

To reiterate: Friends of Mike Steinberg is correct, and I believe that committee, C00504886, is existing, functioning and receiving donations as well as making expenses. In 2012, we did NOT cross the \$5,000 reporting threshold, and therefore did not "report" and we have confirmed in personal visits to your office and over the phone that all is in good order there, other than not having an FEC 2 which is now enclosed. We DID cross the \$5,000 threshold in April, and therefore WILL be submitting the required income / expense report for the period up to and including 4/16th by April 21st.

The "Mike Steinberg for Congress" was the one that was created at the recommendation and by a 3rd party, and for which only a Form 2 was submitted, and should be "purged" from your records. It never received any funds or made any disbursements.

Again, sorry for any confusion and/or any erroneous filings that may have taken place.

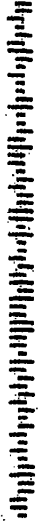
