Schedule H4 Line 21a includes a number of receipts for the payment of rent and copies which are treated as refunds of H4 disbursements. The Democratic Party of Oregon shares office space with other organizations. We write one check to pay rent (Schedule H4 Line 21a). The amount of rent paid by each organization is assessed at the usual and normal charge, determined by the amount of space occupied by the organization. Payments for salaries and wages reported on Schedule H4 are for employees who spent less than 25% of their time on FEA or activities in connection with a Federal election. Employees who spend more than 25% of their time on FEA or activities in connection with a Federal election are paid with 100% Federal funds as are their fringe benefits and reported on Line 30b. Fundraising expenditures are for generic state party fundraising and not on behalf of any candidate. In order to report Prohibited In-Kind Donations for Allocable Activities under FEC guidelines we have had to create fundraising events Direct Mail 01.25.2023 In-kind Fed and Direct Mail 01.25.2023 In-kind Nonfed within our compliance software. It is the only way to generate the required entries within the parameters of our software. These events correspond to the event Direct Mail 01.25.2023. Please note that the transfer from Democratic Grassroots Victory Fund includes contributions originally made to the Fund in 2022, and such contributions are tracked against the donors' respective 2022 limits.
